  - o Construction progress
    - Phase 1 has 3 empty lots remaining
    - Phase 2 has 6 completed homes and 4 under construction. Grass should be at 70% by July.

  - o 2014 income statement: Income \$29,000, expenses \$31,097.

  - o 2015 trends
    - Pool Operations (PH Pool). PH pool was recognized for doing a good job with maintaining the pool and will be swapping out the chlorinator to save material expenses.
    - Pool Loan
      - \$105,000 Loan triggered on 20 houses sold since installation
      - October 2013 initial payment of \$10,000
      - \$7500 paid Oct 2014. Principal only minimally decreased. Will need to accelerate payment amounts.
    - Landscaping (Bear Creek). Will commence once there is no chance of a freeze.
    - Insurance.
      - Pool is well insured.
      - · Liability insurance is in effect.
